#### ПРОГРАММА СОВЕЩАНИЙ ИКАО НА 2021, 2022 И 2023 ГОДЫ

На 10-м заседании своей 221-й сессии, состоявшемся 18 ноября 2020 года, Совет утвердил программу совещаний ИКАО на 2021 год, а также предварительно утвердил в целях планирования и составления бюджета программу совещаний на 2022 и 2023 годы.

Программа совещаний на 2021 год, приводимая в дополнении А к настоящему документу, утверждена с учетом того, что даты проведения некоторых совещаний будут определены позднее. Периодически обновляемый график совещаний размещен в сети ICAO-NET (http://portal.icao.int/).
