In connection with the letter dated March 26,2019 №9-421 and your Letter №68754916-502-E/7355 dated April 10, 2019, regarding to establish the principle of double designations on the routes Moscow – Dalaman and v.v. and Moscow – Bodrum and v.v.


Russian side proposes to establish the principle of double designation on the routes Moscow – Dalaman v.v. and Moscow – Bodrum v.v. **with 7 frequencies for each route assigned to the second designated airlines of both sides.**

With your referenced letter we have received your temporary administrative approval for İstanbul - Samara/ Voronezh and Krasnodar points in 2019 Summer Season. Additionally, the double designation principle proposal for Bodrum-Moskova v.v. and Dalaman-Moskova v.v. routes in your referenced letter is welcomed by our side and as stated, this letter with your referenced letter constitutes an agreement between our Authorities.

Moreover, regarding the planned consultations and workshop between our Authorities, your proposal to hold these events in June, 2019 is welcomed by our side.
