Operation of charter flights to Cyprus

I wish to refer to the subject in heading and to inform you that the Aeronautical Authorities of Cyprus propose and are willing to extend the period of non coordination for the operation of charter flights from Moscow and St. Petersburg to Cyprus.

The current arrangements which were agreed last year between our two countries allow the operation of such flights for the period of 1st June to 20th of September of each calendar year. Our proposal is that in paragraph 3.2 of the MoU of 16th March 2012 the reference to this period is amended as follows: "This coordination will be in force for the routes between Moscow and St. Petersburg to Larnaka and/or Pafos, except for the period of the 15th of March until the 15th of November of each calendar year".

We are confident that the proposed amendment to the MoU will be beneficial for the travelling public.

Your response to this proposal will be highly appreciated. I remain at your disposal for any further clarification.

Aeronautical Authorities of the Russian Federation present its compliments to the Aeronautical Authorities of the Republic of Cyprus and you personally and wish to refer to your letter from 7th February, 2013 on the issue of extending the period of non coordination for the operation of charter flights from Moscow and St. Petersburg to Cyprus.

The Russian side considered your proposal and has the counteroffer to amend paragraph 3.2 of the MoU of 16th March 2012 as follows: "This coordination will be in force for the routes between Moscow and St. Petersburg to Larnaca and/or Pafos, except for the period of the 15th of April until 31st of October of each calendar year".

If our offer is acceptable, your positive answer and this letter will be considered as an agreement between the Aeronautical Authorities of Russia and Cyprus.
