Applicability – RRJ-95 aircraft

State of Manufacture – Russian Federation

Corrective actions described herein are mandatory. No operator may operate an aircraft to which this AD applies, except in accordance with the requirements hereof.

Due to incorrect reference in items 2 contained in SCAC's Technical Decision RRJ0000-OR-470-3016/A dated 31.07.2019 and Airworthiness Directive (further – AD) No. 2019-FATA-01020A-06 dated 05.08.2019 as regards to one-time inspection of the bearings of links of tracks of section 1 of a slat of LH and RH outer wing.

WE PROPOSE:

1. Item 2 of AD No. 2019-FATA-01020A-06 dd 05.08.2019 shall be amended to read as follows:

"During the weekly WY-Check/8 DY on RRJ-95 A/C MSN 95007-95220 to perform inspections of links of tracks (See Fig.3 items16, 27 and 31) and bearings of links of tracks of section 1 of a slat of LH and RH outer wing in accordance with provisions of p. 4. B. (2) and (7) of AMM Task No. 57-42-00-220-802.

Note: Until next scheduled AMM revision – to be guided by AMM Task No. 57-42-00-220-802 dd 28.06.2019 distributed via Information Letter No. 57-0914-19 rev.00".

2. In case AD No. 2019-FATA-01020A-06 is implemented subject to the recommendations provided for in the Information Letter No. 00-0913-19 until 19.08.2019 – this AD is to be considered implemented subject to the requirements of AD No. 2019-FATA-01020A-07 dd 19.08.2019

- 3. Implementation of AD No. 2019-FATA-01020A-06 dd 05.08.2019 starting from 20.08.2019 is to be performed based on the amendments introduced by AD No. 2019-FATA-01020A-07 dd 19.08.2019 and Decision No. RRJ0000-OR-470-3016/B dd 13.08.2019.
- **4.** In cases listed in items 2,3 hereof when filling in the operational documentation and reports on AD implementation to complete them with the following record "AD No. 2019-FATA-01020A-06 dd 05.08.2019 is implemented".

TECHNICAL DECISION RRJ0000-ØR-470-3016/B

on continued airworthiness of aircraft type RRJ-95 in connection with finding of cracks on inner ring of bearings of link of track of slat section

In the course of implementation of AD Nos. 2019-322-03 and 2019-322-05 on RRJ-95 A/C fleet the cracks on inner ring of a bearing of link of track of a slat section I have been revealed. In order to timely detect and eliminate the identified non-conformity as regards to link of track of a slat section, as well as to identify the nature of non-conformity and further actions to be implemented on link of track of a slat section I the following shall be adopted

DECISION:

1. During the weekly WY-Check/8 DY on RRJ-95 A/C MSN 95030, 95037 and from 95116-95220 to perform inspections of links of tracks (See Fig.1 (items1,2) and Fig.2 (item 3) and bearings of links of tracks of sections 2, 3 and 4 of a slat of LH and RH outer wings in accordance with provisions of p. 4. B. (2) and (6) of AMM Tasks Nos. 57-43-00-220-802, 57-44-00-220-802 and 57-45-00-220-802 until the implementation of SB No. RRJ-57-00451-BD "Wing – Replacement of link of track of a slat section".

NOTE: Until next scheduled AMM revision – to be guided by AMM Tasks Nos. 57-43-00-220-802, 57-44-00-220-802 and 57-45-00-220-802 dd June 28, 2019, distributed via Information Letter No. 57-0824-19.

2. During the weekly WY-Check/8 DY on RRJ-95 A/C MSN 95007-95220 to perform one-time inspection of links of tracks (See Fig.3 (items16, 27 and 31) and bearings of links of tracks of section 1 of a slat of LH and RH outer wing in accordance with provisions of p. 4. B. (2) and (7) of AMM Tasks Nos. 57-42-00-220-802.

NOTE: Until next scheduled AMM revision – to be guided by AMM Task No. 57-42-00-220-802 dd June 28, 2019, distributed via Information Letter No. 57-0914-19 Rev.00.

3. In case of finding of a crack of link of track and/or destruction and/or press-out of the bearing of link of track of sections 1, 2, 3 and 4 of a slat of LH and/or RH outer wing following the results of implementation of p.1 and 2 hereof – to replace the damaged track link assembly (link of track and bearing):

For slat section 1 – to replace with the current configuration of link of track of section 1 of a slat, IAW AMM Task No. 57-42-00-900-804.

For slat sections 2,3 and 4 – to replace with the configuration of link of track of sections 2, 3 and 4 of a slat IAW identification information in Table 1 and IAW AMM Tasks Nos. 57-43-00-900-804, 57-44-00-900-804 and 57-45-00-900-804.

NOTE:

- 1. Replacement of the damaged link of track of sections 2, 3 and 4 of a slat with the current configuration is allowed subject to continuation of inspections IAW with provisions of p.1 hereof.
- 2. Presence of two or more cracks on one inner ring of the bearing of link of track is considered as destruction of the bearing.
- 4. After replacement of the track link assembly of sections 2, 3 and 4 of a slat to continue the inspections of link of track of the aforementioned sections of a slat of LH and RH outer wing during the weekly WY-Check/8 DY IAW with provisions of p.l hereof and with consideration to the following conditions:
 - 1) In case of partial replacement of track link assembly inspections are to be performed in full scope, including inspection of the replaced items;
 - 2) In case of full replacement of track link assemblies SB No. RRJ-57-00451-BD "Wing Replacement of link of track of slat section" to be considered as implemented, the inspections shall be performed IAW MPD requirements.
- 5. The results of implementation of provisions of paragraphs 1-3 shall be sent to the Operational Situation Center <u>customercare(a.scac.ru</u>.
- **6.** This Technical Decision shall supersede Technical Decision RRJ0000-OR-470-3016/A.

Do the measurement with the set of feelers 0.05 mm (0.002 in) - 0.3 mm (0.01 in) and the metalic ruller [lenght is not more then 100 mm (3.93 in)] on the upper and lower track flanges. Measure the gap between the edge of the metal ruler and the wear on the track surface.

Measure the gaps only in the front part of the track in about 20 mm (0.78 in) distance from the contact point of the front lower support rollers Apply a ruler across the working surface of the track perpendicular to its surface (ref. Fig. 602).

- (3) Inspect the hold-downs (3). Make sure that there are no mechanical damages (nicks, chips, scratches, cracks). Make sure that the attachment nut (4) of the hold-down is not loose.
 - NOTE: If any defects are detected, eliminate them, Ref. SRM.








Detailed Inspection of the Slat Section 1 Tracks 1 and 2 Figure 601
