

MEMORANDUM OF UNDERSTANDING

Delegations representing the Aeronautical Authorities of the Russian Federation, and the State of Qatar met in Kular Lumpur, Malaysia, on 22 October 2024 during the ICAO Air Services Negotiation Event 2024 (ICAN2024), in order to discuss the matters related to the aviation relations between both countries and civil aviation cooperation.

The discussions were held in a cordial and friendly atmosphere. Both delegations expressed their desire to further promote their aeronautical relations in a spirit of cooperation and complete understanding for their mutual benefits.

A list of the members of the two delegations is attached as **Appendix I**.

Both delegations agreed on the following:

1. FREQUENCIES AND TRAFFIC RIGHTS

The designated airline(s) of the State of Qatar will be entitled to operate additional 21 weekly frequencies for passenger/combination services using 3rd and 4th freedom traffic rights with any type of aircraft, for a total of 56 weekly, as follows:

- Moscow (all airports): 07 weekly, for a total of 28 weekly
- St. Petersburg: 07 weekly, for a total of 14 weekly
- Any other points: 07 weekly, for a total of 14 weekly.

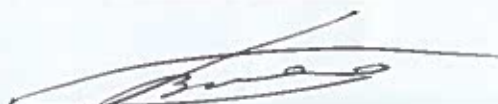
The designated airline(s) of the Russian Federation will be entitled to operate a total of 56 weekly frequencies for passenger/combination services using 3rd and 4th freedom traffic rights with any type of aircraft.

2. ENTRY INTO FORCE

Both delegations agreed that this Memorandum of Understanding shall enter into force on the date of its signature.
