

**MEMORANDUM OF UNDERSTANDING BETWEEN
THE
Civil Aviation Authority OF THE ARAB REPUBLIC OF EGYPT AND THE
Aeronautical Authority of the RUSSIAN FEDERATION**

Delegations representing the Civil Aviation Authority of The Arab Republic of Egypt and the Aeronautical Authority of the Russian Federation, discussed matters relating to air services arrangements between their respective countries.

The following understanding was reached between the Delegations:

1. FREQUENCY AND CAPACITY

Both delegations agreed to increase the number of frequencies operated by the designated airlines of the Arab Republic of Egypt and the Russian Federation between the two countries as follows;

For the designated airlines of the Arab Republic of Egypt the following restrictions on the number of flights shall be established:

- (14) Frequencies per week on sector **Cairo and/or Alexandria - Moscow** and v.v. on each route
- (25) Frequencies per week on sector **Sharm Elsheikh - Moscow** and v.v.
- (25) Frequencies per week on sector **Hurghada - Moscow** and v.v.
- (7) Frequencies per week on sector **Cairo and/or Alexandria - St. Petersburg** and v.v. on each route
- (14) Frequencies per week on sector **Sharm Elsheikh - St. Petersburg** and v.v.
- (14) Frequencies per week on sector **Hurghada - St. Petersburg** and v.v.
- Unlimited frequencies from points in Egypt to points in Russia other than **Moscow & St. Petersburg**.

For the designated airlines of the Russian Federation the following restrictions on the number of flights shall be established:

- (14) Frequencies per week on sector **Moscow - Cairo and / or Alexandria** and v.v. on each route
- (25) Frequencies per week on sector **Moscow - Sharm Elsheikh** and v.v.
- (25) Frequencies per week on sector **Moscow - Hurghada** and v.v.
- (7) Frequencies per week on sector **St. Petersburg - Cairo and/or Alexandria** and v.v. on each route
- (14) Frequencies per week on sector **St. Petersburg - Sharm Elsheikh** and v.v.
- (14) Frequencies per week on sector **St. Petersburg - Hurghada** and v.v.
- Unlimited frequencies from points in Russia other than **Moscow & St Petersburg** to points in Egypt other than **Cairo and / or Alexandria** and v.v.

2. **ROUTE SCHEDULE**


Both delegations agreed on a new route schedule set out as Annex to this MoU, and it will replace Annex of the Air Transport Agreement between the Government of the Arab Republic of Egypt and the Government of the Russian Federation dated December 20, 1994 (ATA) and its amendment in MoU dated 30 August 2005.

3. **Operational flexibility**

Both delegations agreed that the designated airlines of both parties will have the right to operate "W shape flights" in the framework of the existing route schedule and frequency entitlement

4. **ENTRY INTO FORCE**

Both delegations agreed that This MoU shall enter into force and effect on the date of its signature through diplomatic channels

1. Any of the points on the Specified Routes in Schedule I and II of this Annex may at the option of the designated airline of either Party be omitted on any or all flights, provided that these flights originate in the territory of the Party designating the Airline.
2. The Exercise of 5th freedom traffic rights shall be subject to an agreement between the aeronautical authorities of both Parties.
3. The use of Trans-Siberian route system shall be subject to an agreement between the aeronautical authorities of both Parties.
