Dear Mr Tasun,

The Hellenic Civil Aviation Authority presents its comple Policy in Civil Aviation of the Russian Federation.

In reply to your letter dated 03/03/2011, proposing the amendment of the Annex to Air Transport Agreement between the Government of the Russian Federation and the Hellenic Republic, signed December 6<sup>th</sup> 2001, by excluding paragraph "K" of Notes – concerning the operation of charter flights of non designated carriers on agreed routes between our respective countries operated by designated airlines – kindly be informed that there is no objection on our side to accept the above mentioned modification and delete para. "K" of the Annex.

Furthermore, we would like to reiterate that our positive reaction to applications submitted by your air carriers, for charter flights operations in our country is always given, which - being of mutual interest and benefit - contributes towards strengthening our bilateral relations in the field of air transport, developing of tourism and economic ties between our respective countries.

In this context, we have already proposed holding consultations between experts of both sides, in order to explore possibilities of further development of our longstanding aviation relations. This meeting — not yet confirmed by your side — is scheduled to take place in Athens on May 3<sup>rd</sup> and 4<sup>th</sup>.

Awaiting for your confirmation of the proposed dates to hold bilateral negotiations, kindly accept, Sir, the assurances of my highest consideration.

The Department of State Policy in Civil Aviation of the Ministry of Transport of the Russian Federation presents its compliments to National Civil Aviation Administration (NCAA) of the Ministry of Transport and Communications of the Hellenic Republic.

Taking into consideration the position of both Sides directed to the development of air services and tourism between Russia and Greece, we propose to exclude paragraph K Notes of Annex to Air Transport agreement between the Government of the Russian Federation and the Government of the Hellenic Republic dated December 6<sup>th</sup>, 2001.
